#### 9.0 STAFF REPORTS

#### 9.01 Receive the FY 2025 2<sup>nd</sup> Quarter Strategic Performance Report

Mr. Chris Lowery, Strategic & Performance Analytics Manager, and Mr. Andy Brayboy, Senior Corporate Performance Analyst, presented this item with the aid of a PowerPoint presentation and stated during the second quarter the City is building on the solid foundation created in the first quarter with the five key strategic priorities driving tangible positive change. The progress reflects the meaningful impact of initiatives that align directly with the City Council's vision to improve the quality of life for all residents.

In Priority 1: Integrate a Comprehensive Approach to Violence Reduction and Mental Health Response, fifteen collaborative

initiatives have been completed with various community partners, 47 individuals have utilized mental health services through the liaison, working with partners on the mental health co-response model using their established program, and working on the cost of gun violence and violence interrupters to give guidance and help shape policy.

In Priority 2: Continue the City's Commitment to Revitalization Efforts, Emphasizing Affordable Housing Needs, the City has adopted the Section 108 lending policy, provided additional tools to support development projects that aid in revitalization, closing on 3 affordable housing projects leveraging approximately \$3.6 million of City investment, launched the single-family housing development program making 47 lots available for affordable housing. The City has also focused on revitalizing communities by issuing a Request for Qualifications (RFQ) for a historic preservation grant in the Broadell neighborhood, developed the youth engagement center on Murchison Road, and secured funding for 26 new multi-family affordable housing units.

In Priority 3: Increase Parks and Recreation Opportunities for Youth Engagement and Interaction, the City has sustained the Orange Street School project partnership, helped develop diverse programming for youth, promoted and funded the Junior Officials Program, established partnerships to create a Farm-To-Table educational program, provided STEM opportunities through partnerships with Microsoft and Google at the Orange Street School, and developed initiatives for a future International Farmers Market.

In Priority 4: Use City-owned property to Enhance Economic Growth Opportunities Throughout the City, a comprehensive database of surplus real property was created, and a Request of Proposals (RFP) was issued for private developers to explore opportunities to develop affordable housing on City-owned property.

In Priority 5: Articulate/Define Who We Are as a City to Tell Our Story in Fayetteville and Beyond, strategic partnerships allow the City to tell its story through branding efforts, increased media presence, the new City website has had 37,995 visits have landed on the page since going live on February 11, 2025, and continuation of rebranding City signage. The Marketing & Communications Department earned first place in the North Carolina City and County Communicators 2024 Excellence in Communications Award.

The City continues to experience strong financial performance. Through the second quarter, the revenues and expenditures are in alignment with historical trends. The three expenditure types that most reflect operations - personnel services, operating expenditures, and contract services - are aligned with historical trends. Vacancies continue to be a positive and a risk. The largest number of vacancies are in the Police and Fire Departments and are requiring overtime to fulfill service, and there is the potential for increased hiring with the changes at the Federal employment level creating a strain on the vacancy cost savings. Geopolitical and economic pressures will impact the City in various ways such as potential tariffs and Federal funding changes.

Mr. Will Deaton, Planning & Zoning Division Manager, presented this item with the aid of a PowerPoint presentation and stated the owner is requesting a reduction in the 250-foot separation standards between an Automotive Wrecker Service and a residentially zoned property. The applicant's request would reduce the separation down to approximately 10 feet and include a six-foot solid fence.

The Special Use Permit must meet all of the following findings of fact:

- 1. The special use complies with all applicable standards, conditions, and specifications in this Ordinance, including in Section 30-4.C, Use-Specific Standards;
- 2. The special use will be in harmony with the area in which it is located;
- 3. The special use will not materially endanger the public health or safety if located where proposed and developed according to the plan as submitted and approved;
- 4. The special use is in general conformity with the City's adopted land use plans and policies;
- 5. The special use will not substantially injure the value of the abutting land, or the special use is a public necessity; and
- 6. The special use complies with all other relevant City, State, and Federal laws and regulations.

This is the advertised set date and time of the public hearing. The public hearing was opened.

The Special Use Permit shall become effective with the approval of the

Order of Findings by the City Council. The SUP shall expire one year from its effective date if a building permit is not issued within that time. The SUP meets all of the following findings of facts as presented:

- special use complies with all applicable standards, conditions, and specifications in this Ordinance, including in Section 30-4.C, Use-Specific Standards, because all guidelines are followed;
- 2. The special use will be in harmony with the area in which it is located, it will fit in the area due to existing various businesses that are already in the area;
- 3. The special use will not materially endanger public health or safety if located where proposed and developed according to the plan as submitted and approved, because it is located in a heavy industrial district and the vehicles are in a fenced area and not allow the public to enter;
- 4. The special use is in general conformity with the City's adopted land use plans and policies, because the land was previously annexed into the City and rezoned as heavy industrial to store vehicles;
- 5. The special use will not substantially injure the value of the abutting land, or the special use is a public necessity, because it will allow the public to store vehicles; and
- 6. The special use complies with all other relevant City, State, and Federal laws and regulations.
