The Council Committee recognized and noted that this is not an "UDO" issue or even just an "ordinance" issue, but all local and state laws and codes approach and potential policy adjustments to address housing, construction, and development. - 5. Committee working on more focused work for more attainable housing

- 6. Committee working on more focused work for more attainable housing from longer list to specific areas of interest on:
 - A. Accessory Dwelling Units (ADUs)
 - B. PWC Tap Fees
 - C. Stormwater Regulations new versus existing impervious
 - D. Aging of Housing Stock
 - E. Commercial-to-residential conversions
 - F. Increased gentrification and displacement
 - G. State regulatory reform underway (now new laws in place)
 - H. Re-energizing existing Redevelopment Commission and activities



Working on Issues (continued)

- √ 7. Worked through a text amendment addressing more flexibility of parking in various zoning districts.
- ✓ 8. Ongoing work of two departments (ECD and Development Services) on capturing more attainable/affordable housing. Led to full briefing to the City Council in September.

Emerging Issue

"Sidewalks, Landscaping, vegetation, and responsibility/liability" covers areas in Right-of-way, NCDOT and City, private property owners and even what constitutes a sidewalk. PPT of early points to Committee.
