8.0 PUBLIC FORUM

Mr. Archie Barringer, 2271 Genna Shane Drive, Cumberland County, expressed concerns for the need for Unity.

Mr. Michael Currie, 129 Shadyview Drive, Raeford, NC, requested the reinstatement of Little League Baseball.

Ms. Jackie Elliott, 5301 Flagstone Court, Fayetteville, NC, applauded the outstanding use of the ARPA funds in the City.

Mr. Jose Cardona, 233 Addison Street, Fayetteville, NC, expressed concerns regarding the proposed curfew.

Ms. Lisa Lofthouse, 236 Viking Road, Fayetteville, NC, suggested proposed curfew alternatives.

Mr. Chelliko Hurst, 1485 Wayside Drive, Hoke County, expressed concerns regarding the Homeless Day Resource Center.

Mr. Shaun McMillian, 6024 Goldenrain Drive, Fayetteville, NC, expressed concerns regarding the proposed Youth Protection Ordinance.

Ms. Angela Malloy, 131 Hay Street, Fayetteville, NC, expressed concerns regarding the proposed curfew and a public information request.

Mr. Joseph Wheeler, announced the World Homeless Day and an event taking place on facebook live with the Homelessness Assembly.

Ms. Rhonda Shirley, 3514 Gazella Circle, Fayetteville, NC, stated she is in support of the proposed curfew, and the need for an LGBTQUIA Liaison in the Police Department, and encouraged the passing of the Jenesis Law.

After posing the question to the Council, Mayor Colvin announced that as this public forum has exceeded the 30-minute maximum amount of time; the remaining six speakers will be placed on a special public forum for the October 23, 2023, regular City Council meeting. Council Member Benavente objected to Mayor Colvin's announcement.

9.0 PUBLIC HEARINGS (Public & Legislative Hearings)

9.01 Phase 5 Annexation Area 28 and 33 North Public Hearing on the Preliminary Assessment Resolution

Ms. Janelle Rocket, PWC, Interim Marketing Manager, presented this item with the aid of a PowerPoint presentation and stated the City Council approved the Preliminary Assessment Resolution in their meeting on May 8, 2023, for Areas 28 and 33 North of the Phase 5 Annexation. The resolution originally set the date of the public hearing for June 26, 2023, to hear public comment. An additional public hearing is being held on October 9, 2023, to hear public comments.

A notice was published in The Fayetteville Observer on September 26, 2023, and copies of the Preliminary Assessment Resolution were mailed on September 26, 2023, informing the property owners of the public hearing date. After the public hearing, the next step in the process is to approve the Resolution Directing Project be Undertaken. This item will be scheduled for November 13, 2023.

This is the advertised public hearing set for this date and time. There being no one to speak, the public hearing was opened and closed.

9.02 Phase 5 Annexation Utility Improvement Project Area 24BC Public Hearing on the Preliminary Assessment Roll

Ms. Janelle Rocket, PWC, Interim Marketing Manager, presented this item with the aid of a PowerPoint presentation and stated holding a public hearing to receive public comment for Annexation Areas is part of the statutory requirement process.

Preliminary Assessment Notices were mailed on September 25, 2023, informing property owners of their assessments and public hearing date. A notice was published in The Fayetteville Observer on September 26, 2023, for the Preparation of the Preliminary Assessment Roll and Public Hearing.
