The City Council of Fayetteville, North Carolina, does ordain:

The City Council finds the following facts:

(1)With respect to Chapter 14 of the Dwellings and Buildings Minimum Standards Code of the City, concerning certain real property described as follows:

6335 Applecross Avenue PIN 0406-19-0390-

LEGAL: BEGINNING at a point North 10 degrees 44 minutes West, 60.97 feet from the common northern corner of Lots 2 and 3 of Arran Hills, Section 10 as recorded in Plat Book 28, Page 30, Cumberland County, North Carolina Registry, said beginning point being in the northern right of way margin of Applecross Avenue (formerly Hartle Pool Drive) and running with said northern right of way margin of Applecross Avenue, North 69 degrees 03 minutes East 150.00 feet to a point; thence North 19 degrees 12 minutes West 160.00 feet to a point; thence South 69 degrees 03 minutes West 150.00 feet to a point; thence South 19 degrees 12 minutes East 160.0 feet to the beginning. This property is to be demolished and all debris removed from the premises, and the cost of said removal shall be a lien against the real property as described herein.

The lien as ordered herein and permitted by NC General Statute 160D-1203(7) shall be effective from and after the date the work is completed and shall have priority as provided by law, and a record of the same shall be available in the office of the City of Fayetteville Finance Department, Collections Division, 2nd Floor - City, 433 Hay Street, Fayetteville, NC 28301.
