9.01 Acceptance of the FY 2025 1st Quarter Strategic Performance Report

Mr. Chris Lowery, Strategic & Performance Analytics Manager, and Mr. Andy Brayboy, Senior Corporate Performance Analyst, presented this item with the aid of a PowerPoint presentation and stated the Fayetteville City Council is dedicated to fostering a high-performance organization by leveraging data and stakeholder input to develop a forward-thinking, progressive, and outcome-driven strategic plan for the City.

The Mayor, City Council, and City staff share a collective responsibility to ensure that the actions of public officials, employees, contractors, and volunteers align with the City's goals and values. Together, they work to implement policies, budgets, and objectives in the most effective and accountable manner.

During the annual retreat in January 2024, the City Council refined the strategic direction for the City by identifying five key priorities for FY 2025. These priorities were formally adopted at the May 2024 City Council Meeting as part of the City's FY 2025 Strategic Plan.

To ensure progress toward these priorities, the City Manager's Office has tasked the Office of Strategy and Performance Analytics with coordinating regular updates from cross-departmental teams. These updates are reported quarterly to the City Council. The 1st Quarter Strategic Performance Report, as of September 30, 2024, is now presented for Council's review in preparation for the future Council Retreat.

This commitment to performance management and strategic planning strengthens the City's operations, ensuring excellent services and a high quality of life for residents. The alignment of long-range planning with departmental operations and performance expectations allows for effective resource allocation and fosters a culture of continuous improvement. 10.0 PUBLIC HEARINGS (Public & Legislative Hearings)

10.01 P24-38. Rezoning from Single Family Residential 10 (SF-10) to Mixed Residential 5 (MR-5) located at 770 Ocarina Cir (0530203374000) totaling 7.10 acres ± and being the property of James E & Jane L Wood.

Mr. Craig Harmon, Senior Planner, presented this item with the aid of a PowerPoint presentation and stated the applicant has requested to rezone 770 Ocarina Circle from Single Family Residential 10 (SF-10) to Mixed Residential 5 (MR-5). The property is located south of McArthur Road between Rosehill Road and Ramsey Street. This request was reviewed by the Zoning Commission on September 10, 2024. Following a public hearing with three speakers in favor and 15 speakers in opposition, the commission voted to recommend approval of the request (2-1). Most of the opposition's concerns centered on their perception that increased development in this area would lead to traffic issues and increased crime.

This is the advertised set date and time of the public hearing. The public hearing was opened.

Mr. Jonathan Charleston, legal counsel for the property owners, 201 Hay Street, Fayetteville, NC, appeared in favor.

Ms. Christine Main, 4236 Deadwyler Drive, Fayetteville, NC, appeared in opposition.

There being no one further to speak, the public hearing was closed.

Council Member Benavente moved to approve the map amendment to MR-5 based on the following: The proposed zoning map amendment does implement the policies adopted in the Future Land Use Plan (FLUP), and those policies found in the Unified Development Ordinance (UDO). The uses permitted by the proposed change in zoning district classification and standards apply to such uses are appropriate in the immediate area of the land to be reclassified due to the existing zoning and uses surrounding this property; and There are no other factors that will substantially affect public health, safety, morals, or general welfare.

10.02 TA24-11 - Tobacco and Hemp Retail Amendment

Mr. Will Deaton, Planning and Zoning Manager, presented this item with the aid of a PowerPoint presentation and stated included in your packet is the proposed text amendment to the Unified Development Ordinance to regulate tobacco and hemp retail products based on the recently adopted Cumberland County Ordinance.

At the City Council's January work session, a council request was made asking staff to review a proposed ordinance change by Cumberland County. The Cumberland County proposed text amendment and definition was approved by the Cumberland County Commissioners on January 16, 2024.

Upon the City Council's direction from the May 6th work session, this item went before the Planning Commission for a legislative hearing and recommendation, with a focus on regulation of tobacco and hemp retail through the principal use of the subject property. Following the Planning Commission's recommendation, the proposed text amendment will be presented to the City Council, this time for a legislative hearing, review, and decision.

The proposed amendment to the City's ordinance is similar to the text that was adopted by the Cumberland County Commissioners. However, the City's proposed ordinance change expands the separation distance to 1,000 feet and includes religious institutions. Legal provided clarification regarding the ability of local governments to provide for distance separation from specific uses as intended by the requested text amendment.
