Mr. Douglas Hewett, City Manager, stated, as shared during the City Manager's Report, staff worked diligently to execute Council's wishes which were for two separate agreements, one for SROs and one for TCOs. The SROs contract will provide us on August 26, 2024, with 6 SROs that will be assigned to roam the 9 high schools in the City limits and starting on January 1, 2025, we hope to hire an additional 3 SROs to have one SRO at each high school. The agreement makes clear with the Cumberland County School (CCS) system that given the recruitment issues and staffing concerns, we will not have a complement of SROs that will be able to work exclusively in the elementary and middle schools and will verify with CCS their plan to handle the security needs at those schools. If there is a 911 call or an emergency, the Fayetteville Police Department will still show up. For the TCOs contract, Police Chief Braden has reported 40 of the 66 TCOs have been hired and another 20 are slated to begin work on August 19, 2024, and will be 6 short of the contract goal of 66 TCOs to work traffic in the morning and afternoon at the 49 schools. Over the next few weeks staff will be working with the Mayor and Mayor Pro Tem to develop a process to look at a longer and more durable agreement.

Mr. Christopher Cauley, Economic and Community Development Director, presented this item and stated this is largely a paperwork and regulatory process. The Internal Revenue Service (IRS) has regulations in its code for projects that help communities that require local governing boards approve a resolution stating the project makes sense in the community which allows private developers to access very good interest rates and lending models.

There are two projects that are currently underway in the community. In December of 2022 the projects came before the City Council for the same process. As the projects go through the process and access financing, there is a one-year time limit that the approval is good for. Because the one-year time limit has elapsed, another public hearing is required for IRS tax compliance purposes and follow staff's recommendation to approve a resolution so GoodHomes, Inc., and their private developer partners can continue the projects and access the financing terms.
