Adoption of Budget Ordinance Amendment (BOA) 2019-2 will appropriate \$514,148.00 from Airport Fund net assets to transfer to the Airport Capital Fund. These funds will be used along with \$630,981.00 of funds previously transferred from the operating fund, \$797,412.00 of Passenger Facility Charge (PFC) revenue and \$138,459.00 of interest earnings on PFC revenues to fund the additional \$2,081,000.00 appropriation on proposed Capital Project Ordinance Amendment (CPOA) 2019-17.

### 6.03 Adoption of Special Revenue Fund Project Ordinance 2019-1 for the 2017 FPD Educating Kids on Guns Program Grant

The City of Fayetteville has been awarded a grant from the North Carolina Department of Public Safety, Governor's Crime Commission to continue the Police Department's Educating Kids about Gang and Gun Violence (EKG) program. The pass-through grant award is funded by the Federal 2017 Juvenile Justice Delinquency Prevention grant program. Special Revenue Fund Project Ordinance (SRO) 2019-1 will establish a project appropriation of \$27,578.00, with \$20,683.00 (75 percent) funded by the Federal grant funds and the \$6,895.00 (25 percent) required local match funded by a transfer from the General Fund.

### 6.04 Adoption of Capital Project Ordinance Amendment 2019-13 to Appropriate Payment in Lieu of Resurfacing Revenue to the FY 2019 Street Resurfacing Project and Award a Contract for Resurface of Various Streets, 2019 - Phase 1

**6.013 Economic & Community Development 2018-2019 Annual Action Plan**

Ms. Cynthia Blot, Economic and Community Development Director, presented this item and stated the 2018-2019 Annual Action Plan is based on priorities, goals, and objectives of the 2015-2019 Consolidated Plan. This plan is a comprehensive plan addressing the City's housing, homeless, community development, and economic development needs through 2019. The plan contains goals, objectives, and implementing strategies for each of the plan's elements. The Annual Action Plan describes the activities to be funded or implemented and is consistent with the 2015-2019 Consolidated Plan. In an effort to provide citizens an opportunity to participate in the process of developing the Annual Action Plan, the Economic & Community Development staff held six citizen participation meetings. These

meetings were held in various locations throughout the City. A staff public hearing was held on February 15, 2018, and the Fayetteville Redevelopment Commission held a public hearing on March 8, 2018. A draft copy of the plan was made available in various locations for review and comments for 30 days from March 27 through April 26, 2018. On May 1, 2018, the City received notification from HUD of the 2018-2019 allocation and will receive an increase of \$385,021.00 compared to the original allocation. An additional 30-day comment period was required (June 18 through July 17, 2018). No comments were received. Staff is requesting Council consider adopting the 2018-2019 Annual Action Plan. The City's Community Development Block Grant (CDBG) allocation and HOME Investment Partnership Grant (HOME) allocation notification was received May 1, 2018. The City will receive an increase of \$385,021.00. Adjustments were made to the plan and staff is requesting final approval of the 2018-2019 Annual Action Plan. There is no budget impact; the HOME Investment Partnership Grant match from the City has been waived for 2017 and 2018 due to Hurricane Matthew.

Ms. Kecia Parker, Real Estate Manager, presented this item and stated in June of 2018, Real Estate staff was given the direction to acquire four parcels for downtown parking. Staff did all research and found that one parcel had IRS liens that would require condemnation for clear title. One owner was contacted by staff and was informed that the parking lot was currently being leased by an adjacent restaurant and they were not interested in selling at this time. The other two parcels are owned by several people. Real Estate staff tried to contact the owners, but received no response. Staff had previously called one of the owners last year to determine if they were interested in selling and were informed that one of the owners was unable to be found which would also require condemnation. At that time they were not interested in selling the property. On August 6, 2018, the City Council decided to pursue these purchases by filing condemnation action.

Discussion ensued.

**9.03 Settlement for Fiscal Year July 1, 2017, through June 30, 2018**

The City of Fayetteville has a continuing contract with Cumberland County, which provides that the County Tax Collector shall act as the City Tax Collector. The Cumberland County Tax Administrator annually sends a copy of the settlement to the City. The report includes the July 1, 2017, through June 30, 2018, Settlement Statement and the Verification of Tax Funds for Fiscal Year Ended June 30, 2018. As required by N.C.G.S. § 105-373, a copy is on file with the Board of County Commissioners. The settlement shows the amounts that the Tax Collector was charged with collecting as well as amounts collected, released, uncollected, and barred. The summary of 2007 Real/Personal & Vehicle Taxes to be Barred includes uncollected taxes that are barred from new collections actions, as stipulated by N.C.G.S. § 105-378 (because the ten-year collection period has passed). The Verification of Tax Funds for the Fiscal Year Ended June 30, 2018, presents the Current Year Original Levy, Discoveries and Releases, Amounts Remitted to the City, Interest, and Amounts Due to the City.
