### 8.0A2 Adoption of Capital Project Ordinance Amendment to Appropriate Payment-In-Lieu-of Resurfacing Revenue to Street Resurfacing Projects

Payment in-lieu of resurfacing has been collected from utility companies. In accordance with the provisions set forth in Chapter 24, Article II, Section 24-72 of the City Code Ordinances, Public Services desires to utilize the funds for the FY23 pavement preservation project to be used for street resurfacing. Capital Project Ordinance Amendment (CPOA) 2025-47 appropriates \$224,844.00 of revenue received from payments-in-lieu of resurfacing for the FY2023 Pavement Preservation project.

### 8.0A3 Revisions to the Homebuyer HERO Programs

The City Council approved the following changes to the Homebuyer HERO Program: revise the Public Service HERO to include all federal, state, and local government employees and retirees, all public and private healthcare professionals and retirees, and employees and retirees of public and private educational schools and institutions; revise the City Employee HERO to provide funding up to \$30,000, include City of Fayetteville retirees, and allow for immediate eligibility upon hiring. The requirement of 1 year of employment will remain in effect and be secured with a Deed of Trust and Promissory Note for the full amount of assistance; and remove the first-time home buyer requirement from all three programs to allow for move-up buyers, with the condition that the applicant cannot own a home, solely or jointly, at the time of closing.

# 8.0A4 Adoption of Special Revenue Fund Project Ordinance Amendment and Authorization to Accept Additional Grant Funding for the Conservation Restoration Plan for Cross Creek Cemetery #1

The City Council adopted Special Revenue Fund Project Ordinance Amendment (SROA) 2025-3 to appropriate a \$5,000.00 grant award from the Cumberland County Foundation. The grant will be funds will be used to complete the Cross Creek Cemetery Conservation Plan Phase 1.

# 8.0A5 Resolution Calling for Public Hearing Regarding the Permanent Closing of a Portion of Bullock Street

The City Council adopted a resolution to call for a public hearing on June 23, 2025, on the closing of a portion of Bullock Street between Sapona Road and Haywood Street to allow for the connection and future development of the Sapona Road Church of God property. The street portion to be closed will not deny access to any property owners and has never been constructed on or opened.

## 8.0A8 PWC - Bid Recommendation - Two (2) Prefabricated Concrete Relay Control Houses for the Cliffdale and Yadkin Substations

City Council approved the bid recommendation to award the purchase of two prefabricated concrete relay control houses for the Cliffdale and Yadkin Substations to VFP Inc., of Roanoke, VA, the lowest, responsive, responsible bidder and in the best interests of PWC, in the total amount of \$509,967.50, and authorize the General Manager of the Fayetteville Public Works Commission to execute for that purpose the contract for its purchase.

### 8.0B7 Ordinance Requiring Towing Operators to Clean Accident Site

Mr. Joshua Hall, Police Attorney stated, at the request of City Council, the City Attorney's Office researched whether the City could enact an ordinance requiring all tow/wrecker operators to clear debris from accident sites within the City of Fayetteville. Currently, there is no ordinance requiring such. However, wrecker operators on the City's approved wrecker rotation list are required to clean debris from crash sites.

The proposed ordinance will require all tow/wrecker operators in the City of Fayetteville to clean up accident sites.

# 9.01 Presentation of the Recommended Fiscal Year 2025-2026 Annual Operating Budget and Setting of the Budget Public Hearing

Dr. Douglas Hewett, City Manager, thanked Mr. Jeffery Yates, Assistant City Manager and the entire Budget and Evaluation staff for their efforts. Dr. Hewett stated the Fiscal Year 2025-2026 City Manager's Recommended Budget will be presented and has been challenging to create partially due to the revaluation, but also because it is the end of the sales tax agreement with Cumberland County. The budget is one of the key documents that guide the City's development and its operations. It begins with the City Council's strategic plan, the capital improvement projects, the operating budget, and finally the financial audit.

Mr. Yates presented this item with the aid of a PowerPoint presentation, and stated this is the Managers recommended budget. This fulfills the Local Government Budget and Fiscal Control Act (LGBFCA) requirement to submit a balanced, recommended budget for the upcoming fiscal year to the governing board not later than June 1st each year. Council can now deliberate the budget through several work sessions throughout the month of May.

The three core budget principles are to focus on employees, maintain services and commitments, and focus on high-value, high-impact additions. The total recommended budget is \$8.5 million less than 2025. Staff are recommending \$4.6 million in the General Fund for employee compensation and assumes a vacancy rate of 7.4 percent. The recommended ad valorem tax rate is \$.4495 which was recommended due to the lost sales tax revenues, reduced motor vehicle ad valorum revenue, compensation increases for employees, annual funding for Police Department axon technology and video storage, and new investments.

There is no recommended rate increase for stormwater or solid waste; and recommend maintaining the current fares for FAST.

Recommended new investments per strategic plan include \$1.9 million in Goal 5 with the largest amount being dedicated to the Construction management division. \$130,000.00 in new investment for Goal 6, \$422,000.00 in new investment for Priority 1, and \$692,000.00 in new investment for Priority 2.

Mr. Yates reviewed General Fund sources and uses and the current parking lot items which include a parking study for \$150,000.00, additional public safety cameras, BriefCam AI software, Festival Park security upgrades, and right-of-way maintenance temp staffing at \$440,000.00.

Discussion ensued.
