**5.0 CITY MANAGER REPORT**

Dr. Douglas Hewett, City Manager, stated the City and Fayetteville Metropolitan Housing Authority have successfully submitted the Choice Neighborhood Application requesting \$26 million of grant funds from the Housing and Urban Development Department (HUD) and includes more than \$531 million in committed public and private leveraging support for a transformation along the Murchison Road corridor. This level of partnership and investment will be historic and monumental for the community if we receive the award.

Dr. Hewett stated the City continues to grow a strong and stable budget and financial team. Assistant Finance Directors, Ms. Kimberly Toon and Ms. Amanda Mott have passed the required examination to be awarded the North Carolina Government Finance Officers Award for Certified Local Government Finance Officers. Ms. Kymberly Locklear, Assistant Purchasing Manager was awarded the designation of North Carolina Contract Manager and Economic Inclusion Officer from the University of North Carolina School of Government. Ms. Brandy

Darden, Purchasing Analyst has been awarded the North Carolina Local Government Purchasing Officers Designation.

**7.0A5 Agreement with Cumberland County for Joint Funding of Year-Round Temporary Emergency Shelter**

City Council authorized the City Manager to execute an agreement with Cumberland County for joint funding of a year-round temporary emergency shelter, appropriate \$100,000.00 of general fund balance, and complete all corresponding budget and financial actions.

**7.0A6 To Accept and Appropriate the Emergency Management Disaster Relief and Mitigation Fund Grant and to Authorize the City Manager to Execute a Memorandum of Agreement with North Carolina Emergency Management for the Locks Creek Roadway and Culvert Flood Mitigation Project**

City Council accepted the Emergency Management Disaster Relief and Mitigation Fund (DRMF) grant in the amount of \$999,135 for the Locks Creek Roadway and Culvert Flood Mitigation Project. City Council also authorized for the City Manager to execute a Memorandum of Agreement (MOA) with the North Carolina Emergency Management and to adopt Capital Project Ordinance (CPO) 2026-36 to appropriate the grant funding. The project improvements will provide upgrades to the existing culvert on Locks Creek Road and raise the roadway elevations to maintain and enhance community access during storm events up to the 50-year level of service.

**7.0A7 Approval/Renewal of Agreement with Transportation Network Companies**

City Council approved the proposed agreement to be used with transportation network companies such as Uber and Lyft that may desire to provide pick-ups and drop-offs at the Fayetteville Regional Airport and authorize the City Manager to execute the agreements on the behalf of the City. The term of the agreements shall be for three years.

**7.0A8 PWC - Approve Sole Source Request - Purchase Twenty (20) LTE-Enabled Wastewater Flow Monitor Units, Twenty (20) Antennas for Communications, Ten (10) Area-Velocity Flow Sensors**

City Council approved the sole source request to purchase twenty (20) LTE-enabled wastewater flow monitor units, twenty (20) antennas for communications, ten (10) area-velocity flow sensors from ADS Environmental Services LLC in the amount of \$153,405.00 and authorize the CEO/General Manager of the Fayetteville Public Works Commission to execute for that purpose the contract for its purchase.

**8.0 REPORTS FROM BOARDS AND COMMISSIONS**

**8.01 Receive the Fair Housing Board Presentation**

Ms. Yamile Nazar, Human Relations Director, introduced Dr. Melanie Shorter, Fair Housing Board Member, to present the Fair Housing Board annual report. Ms. Nazar announced on Friday, April 17, 2026, from 8:00 a.m. – 5:00 p.m. at Fayetteville Technical Community College the Fair Housing Board will be hosting a Fair Housing and Civil Rights Conference. The cost to attend is \$75.00 and includes breakfast and lunch.

Dr. Shorter stated the Fair Housing Act was enacted as part of the Civil Rights Act of 1968. Housing discrimination includes race, color, religion, sex, national origin, familial status, and disability. Dwellings that are covered under the fair housing act include houses, apartments, and mobile homes for sale or rent, beach rentals and time shares, vacant lots intended for dwellings, nursing homes, long-term shelters, and student housing. Dr. Shorter provided a list of prohibited practices covered under Fair Housing and provided examples of discrimination. The Fair Housing Board is quasi-judicial consisting of 5 members and civil penalties start at \$11,000.00.

## **8.02 Receive the Fayetteville NEXT Annual Report**

Mr. Nathan Cuffee, Fayetteville NEXT Chairman, stated the Commission has been working on a phased approach to grow the NEXT Commission. Phase one consisted of building the foundation of the Commission through the rebranding from Millennial Commission to Fayetteville NEXT, creating structure, clarity, and credibility to establish a Commission with a clear identity, mission and purpose. Phase two focused on relationship building, community connection and impact.

During Phase Two, the Commission hosted several engagement events, including Sweater Socials and Adult Field Days in partnership with Cape Fear Valley Health. The Commission also produced its second annual Business Summit at Fayetteville Technical Community College, which welcomed entrepreneur Denise Woodard back to Fayetteville for the first time in 18 years and included a partnership with the Fayetteville Woodpeckers to highlight local entertainment opportunities. Additional partnerships included youth programming with students from Anne Chesnutt Middle School and collaborations with organizations such as Dick's House of Sport, the Dogwood Festival, and Fayetteville Liberty. Mr. Cuffee stated as the organization's visibility increased, residents had begun reaching out regarding infrastructure, parking, and other civic concerns, which signaled that the community viewed Fayetteville NEXT as a trusted bridge.

Mr. Cuffee stated the Commission has now moved its focus to Phase Three, which focuses on strengthening alignment with the City of Fayetteville and expanding engagement opportunities. To support this effort, the Commission established a Government Relations Committee to create clearer connections between commissioners and city departments and introduced the 910 Future Fest that is tentatively scheduled for September 24-26, 2026, at Segra Stadium. The 910 Future Fest has been in development for over 14 months in partnership with organizations such as The Two-Six Project. The fest will be an annual civic event intended to support youth opportunity, workforce development, public engagement, and downtown vitality.

A video from the Two-Six Project regarding the 910 Future Fest was presented.
