# 7.0A3 Approve Bid Recommendation for a Site Plan Review Process Improvement Study and Authorize the City Manager to Execute a Contract

City Council approved the award of and authorized the City Manager to execute a contract with Berry, Dunn, McNeil & Parker, LLC for consulting services to assess, align, and improve the City's multi-agency sit plan review and development permitting process.

# 7.0A4 Approve P25-45: Request to Initially rezone 2.55 acres (PIN 0425754360000) from county M(P) to LI, owned by CRA Commercial Development, represented by Lori Epler of Larry King & Assoc.

City Council approved the rezoning of approximately 2.55 acres on Black and Decker Road from Cumberland County M(P) to City of Fayetteville LI (Light Industrial) to align the site with the established industrial pattern near Fayetteville Regional Airport. The request is substantially consistent with the Future Land Use Plan text and intent, but inconsistent with the current Future Land Use Map. The Zoning Commission conducted a public hearing on September 9, 2025, and the Commission voted unanimously to recommend approval.

# 7.0A5 Approve Ordinances for Uninhabitable Structures: Demolition

City Council adopted demolition ordinances for the two commercial buildings identified as blight. Should a property come into compliance voluntarily, staff will present a demolition rescission ordinance to Council to formally remove the order from the property deed.

# 7.0A6 Adopt Capital Project Ordinance Amendment & Bid Recommendation – Ivy and Lyon Road Drainage Improvement Project

City Council approved the award and authorized execution of a contract in the amount of \$6,154,032.00 for the Ivy and Lyon Road Drainage Improvement Project, to the lowest responsive and responsible bidder, Roadworks Construction Company.

City Council adopted Capital Project Ordinance Amendment (CPOA) 2024-13 to appropriate an additional \$3,791,397.00 from the Public Works Commission (PWC) for utility improvements associated with the project.

The project aims to reduce the risk of flooding within the City's right of way as well as provide the co-benefit of protecting residential structures from flood damage and improve the overall functionality and stability of Eutaw Creek.

# 7.0A7 Authorization to Accept Grant Funding from Keep America Beautiful for Fayetteville Beautiful and Adoption of Budget Ordinance Amendment to Appropriate Funds

City Council authorized staff to accept the grant from Keep America Beautiful and adopt Budget Ordinance Amendment 2026-3 to appropriate the \$5,000.00 in funding. These funds will directly support our Fayetteville Beautiful program-an ongoing initiative dedicated to engaging the community in litter prevention, environmental education, and the beautification of public spaces across the City.

# 7.0A8 Approve Interlocal Agreement – Joint Use of Facilities with Cumberland County Board of Education

City Council approved the interlocal agreement with the Cumberland County Board of Education to allow the parks and recreation department to utilize both indoor and outdoor facilities at school properties for recreation programming. The City has had a joint-use agreement in place with the Board of Education since 1966 and this agreement will extend through 2028.

## 7.0A9 PWC - Approve Bid Recommendation - Powdered Activated Carbon Slurry

City Council approved the purchase award for the Powdered Activated Carbon Slurry to Brenntag Mid-South, Inc, Durham, NC, the lowest responsive and responsible bidder, and in the best interest of PWC, for the total amount of \$108,900.00, and authorize the CEO/General Manager of the Fayetteville Public Works Commission to execute for that purpose the contract for its purchase.

8.02 AX25-02: CRA Commercial Development LLC is petitioning to annex a parcel of approximately 2.55 acres at 3456 BLACK & DECKER RD (PIN 0425754360000) into the corporate limits of the City of Fayetteville. This parcel is situated on the south side of Black & Decker Road, west of Gillespie Street, near the intersection of Dedication Drive and Black & Decker Road.

Mr. Craig Harmon, Senior Planner, presented this item with the aid of a PowerPoint presentation and stated all the surrounding properties are either City or County industrial properties and the current property is zoned as manufacturing, M(P) which is the County's version of City industrial. There is a housing development to the east and south. The site is currently vacant and falls within an area designated as an Employment Center on the City's Future Land Use (FLU) Map. This land-use designation supports industrial and employment-center activities in the airport area and aligns the City's jurisdiction with expected service delivery.

All future structures and uses on this site will be subject to the Airport Overlay standards and FAA Part 77 airspace review, with restrictions on high-occupancy assembly or bird-attracting uses. Although the parcel is situated within the Employment Center area, parts of the immediate edge are classified as Low-Density Residential on the adopted FLU Map. Staff recommends adoption of the proposed ordinance annexing the property with an effective date of October 27, 2025.

This is the advertised public hearing set for this date and time, the public hearing was opened.

Ms. Lori Eppler, 1333 Morganton Road, Fayetteville, NC, spoke in favor of this item.

There being no further speakers, the public hearing was closed.

# 9.0 STAFF REPORTS

#### 9.01 Receive the Fayetteville Fire Department 2025 3rd Quarter Review

Mr. Kevin Dove, Fire Chief presented this item with the aid of a PowerPoint Presentation and shared third quarter highlights that include, 245 applicants for the 2026 hiring process, 25 recruits graduated the fire academy, and the Urban Search and Rescue (USAR) team trained on the new "House Under Water" prop at the Fayetteville Tech Regional Training Center which is the first of its kind in the world.

Chief Dove stated there were 7,593 calls in the third quarter, with the bulk of calls being for rescue/EMS. Response times remain consistent and under the 8:00 minute response. The Department responded to 206 fires, there were no civilian fire fatalities, but 8 civilian injuries and 3 firefighter injuries. The top three fire losses included an apartment complex, a single-family structure, and a commercial structure. The number of medical responses and hazardous materials responses were presented.

There were 6 firefighter and 1 fire inspector vacancies at the end of the quarter, however, after graduating the most recent academy there are no longer any firefighter vacancies, but still and 1 inspector vacancy. The department is 25% underrepresented population and is the highest it has been during Chief Dove's tenure.

There has been a significant makeover of the Fire Marshal's Office with the overarching goal to have everyone doing business in the City safely while meeting the state fire code. There were 881 new plan reviews, 2541 fire inspections/maintenance and 6301 fire code violations recovered; however, 47% of the violations are identified and corrected at the same time and does not require reinspection. Further education for the business owners will be provided by the Fire Marshal's Office and Community Risk Reduction to help set businesses up for success. Top five violations are electrical hazards, fire extinguishers, general, emergency and standby power systems, and fire protection and utility equipment identification and access.

Community risk reduction engaged 6,655 residents through 164 community events. 343 smoke alarms and 84 Carbon Monoxide alarms were installed.

If you need a smoke alarm installed or checked, call 910-433-1116, and it will be provided and installed at no cost.

Discussion ensued regarding how the Fire Department manages mental health.

#### 9.02 Receive the Fayetteville Police Department 3rd Quarter Review

Mr. Roberto Bryan, Chief of Police, presented this item with the aid of a PowerPoint presentation and stated the third quarter report will cover January through September 2025 and discuss crime statistics, trends, strategies, and community engagement. Total crime is down by 10 percent (%) and arrests are down by just over 1%. There was a large number of homicides at the beginning of the year but have been trending down over the rest of the year. The homicide unit is maintaining a clearance rate of 87.5% while the national average is 58%. The number of overdoses and suicides were also presented. Domestic aggravated assault is trending down for misdemeanors and simple assaults, but felony aggravated assault is up by 1.3%.

ShotSpotter had 334 alerts; with 126 alerts, 2 guns recovered and 3 resulting in arrest in the Campbellton district; 90 alerts, 1 gun recovered, and 2 resulting in arrests in the Central district; and 124 alerts, 14 guns recovered, and 9 resulting in arrests in the Cross Creek district. The ShotSpotter dashboard was reviewed and stated IT and members of the City Manager's team are working on coming up with a set of categories instead of the "blank" category. A video of a ShotSpotter report was presented, which was categorized as a blank because it did not have a 911 call or witnesses, and until the found shell casings can be linked to a case or crime. Chief Bryan stated an analyst listens to every single alert.

Discussion ensued. Ms. Kelly Strickland, Assistant City Manager, stated staff have created a working group that includes the Police Department, Office of Community Safety (OCS), the City Manager's Office, and the Strategic Planning & Analytics Department to close the gaps in the data and identify a better and more consistent way of managing the data.

Chief Bryan presented information on the federal and state task force partnerships; property crimes such as burglary, larceny, motor vehicle, and other property crimes are down with the exception of robbery which is up by 1.2%.

Juvenile crimes are up by 17%, with the most pressing issue being robbery, which has almost doubled in a year. The curfew from 11 p.m.- 6 a.m. has resulted in a total of 31 incident charges. Council Member Benavente asked if the curfew was the impetus for officers approaching a young person. Chief Bryan explained the approaches were because of other identifying crimes; it will take time to determine the impact the curfew has on juvenile crime.

The Police Department is collaborating with the OCS. They hold weekly meetings to align priorities, and OCS has directly responded to 32 unhoused community related calls. Furthermore, OCS has integrated 2 Police Department staff into their department to enhance cross-departmental collaboration.

There have been a total of 267 calls for service responded to through the School Resource Officer (SRO) Program with 95 incident reports. Currently, there are 14 certified SRO's and it is expected to increase to 18 in January, 2026.

The number of narcotics seized, and the 911 telecommunications calls for service were reviewed.

Traffic enforcement has seen 19 fatal crashes resulting in 21 deaths and the only way to address those is with enforcement. There have been 40,342 traffic stops, with a breakdown of 13,626 white drivers, 25,156 black drivers, and 1,718 other drivers. Out of the 873 of black drivers searched, 537 drugs and 231 weapons were seized; out of the 215 white drivers searched, 131 drugs and 27 weapons were seized; and out of the 37 other drivers searched, 28 drugs and 8 weapons were seized. Discussion ensued on traffic enforcement.

The Internal Affairs Unit has reviewed 50 use of force, completed 49 internal investigations, received 28 citizen complaints and 32 positive compliments, 31 vehicle pursuits, and 48 crashes. Based on the investigations, disciplinary actions can include coaching and training action, policy warning, oral counseling, written reprimand, suspension, demotion, or dismissal/termination. Chief Bryan reviewed the current departmental staffing and stated there are 60 vacancies, which do not reflect the 65 frozen positions. Discussion ensued regarding applicants.

Chief Bryan presented photos from the National Night Out, Coffee with a Cop, Special Olympics Events, First Responders Night at Segra Stadium, and the Promotion and Graduation Ceremony.

Council Member Haire requested an update on speed centuries and new camera technology. Chief Bryan stated it is a phased approach, starting with updating the server room and have now deployed several speed centuries with more on order to include the school zones.
