Composition of Members

The City Council shall appoint thirteen (13) members representing a diverse cross-section of the community. Members must reside within the City of Fayetteville. The initial appointments shall consist of seven members each to serve an initial term of two years, and six members each to serve an initial term of one year. Appointments after the initial appointments shall be for a period of two years. The initial term limits will be determined by the City Council based on recommendations of the Mayor and the Appointments Committee. Each initial appointment shall be eligible for an additional two-year term, but shall not be re-eligible for reappointment thereafter without at least one year intervening between appointments, per City Council Policy # 110.2. A four - person Executive Advisory Board - defined as a Chair, Vice Chair, Secretary and Director of Programs - will be created with a City Council Member and staff member as liaisons.
