**Description of Project:** The City of Fayetteville is replacing four (4) LTV Paratransit vehicles and two (2) LTVs used for fixed route services. These vehicles have exceeded their useful lives bench marks. The paratransit vehicle will be replaced with like 22ft and 25ft vehicles with high floors and wheelchair lifts. The fixed route vehicles will be replaced with low-floor light vehicles with ramps. The vehicles being replaced will be removed from service and disposed. The funding for the fixed route vehicles was secured via grant amendment to NC-20-016.
