Background and Scope

The City of Fayetteville Housing and Code Enforcement Division requested quotes for lot cleaning, asbestos abatement, demolition, and site restoration services for the property located at 511 S. Eastern Boulevard. The project is associated with City Code Enforcement action and is the result of a Council-approved demolition ordinance for the subject property.

The work includes demolition and removal of all primary and accessory structures, removal and proper disposal of personal property and debris, vegetation clearing, grading and site restoration, disposal of materials at approved facilities, safety and site security requirements, and all permits, inspections, licenses, bonds, insurance, engineering, and approvals necessary to complete the work. The scope also requires identification and abatement of asbestos-containing materials, where applicable, by properly licensed personnel in accordance with all applicable regulations.

Based on the asbestos inspection and testing information included with the solicitation, asbestos-containing building materials were not found in the hotel section but were found in the conference room/print shop area. The successful contractor is required to perform and document all abatement and disposal work in compliance with applicable local, state, and federal requirements. The solicitation requires completion within ninety (90) calendar days from issuance of the Notice to Proceed, unless otherwise approved in writing.

Bid Summary

The Request for Quotes was advertised, and the City received seven bids. The bid results are summarized below:

Bidder Responsibility and Compliance Review

Following the bid opening, the Procurement Department prepared a Procurement Vendor Qualification & Compliance Package for the apparent low bidder. The package included review of the bid bond, surety information, business registration, North Carolina General Contractor license information, insurance documentation, and reference checks. The package supports the recommendation that Pink Ribbon Hauling LLC be considered responsive and responsible for award.

Reference Checks	Reference checks were completed with Tony Faircloth, Jason Gittleton, and Tommy Beard. The references indicated that Pink Ribbon Hauling LLC stayed within the quoted amount, performed lot clearing and demolition/hauling work, completed work professionally, and was recommended for future work.

Procurement Vendor Qualification & Compliance Package

The Procurement Vendor Qualification & Compliance Package was prepared by the Procurement Department as the supporting vendor compliance record for this award recommendation. The package documents the vendor's bid bond, insurance, business registration, licensing, surety verification, and reference checks used to support the award recommendation.

Evaluation

Pink Ribbon Hauling LLC submitted the lowest bid in the amount of \$277,656.00. The bid tabulation indicates that the required bid bond was provided, and the issued addendum was acknowledged.

The Procurement Vendor Qualification & Compliance Package shows that Pink Ribbon Hauling LLC is current-active with the North Carolina Secretary of State, holds North Carolina General Contractor License No. 107264, submitted a five percent bid bond through West Bend Insurance Company, provided evidence of insurance, and received favorable reference checks. The documentation further indicates that the surety and bond information were reviewed for compliance, including confirmation of the power of attorney and surety registration information.

Recommendation

Staff recommends that City Council award the contract for the Lot Cleaning, Asbestos Abatement and Demolition Project at 511 S. Eastern Boulevard to Pink Ribbon Hauling LLC in the amount of \$277,656.00 and authorize the City Manager or designee to execute the contract and any related documents necessary to complete the work.

Approval of this award will allow the City to proceed with the required demolition, abatement, lot cleaning, and site restoration activities necessary to address the unsafe and noncompliant conditions at the property in accordance with City Code Enforcement requirements.

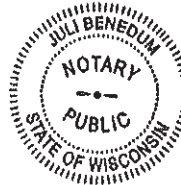
