In accordance with North Carolina General Statute \$158-7.1(c), the purpose of the hearing is to receive public comments on a proposed on the proposed allocation of funds for economic development. The Council shall consider a request to appropriate \$1,250,000 to the "Community Development Foundation" to Support the creation of an "Economic Equity Fund". The intent of this program is to support the creation and expansion by locally owned companies operating in or employing residents of census tracts designated as low-moderate income. In order to receive funding, companies will be required to meet performance criteria including job creation and financial reporting. Failure to do so will require repayment.

NOTICE IS HEREBY
GIVEN that a public hearing will be held by the City of Fayetteville, North Carolina (the "City"), on December 12, 2022, at 7:00 p.m. (or as soon thereafter as practicable) in the City Council Chambers at 433 Hay Street, in Fayetteville, North Carolina regarding the proposed issuance by the Prublic Finance Authority (the "Issuer") of its qualified 501(c)(3) bonds, as defined in Section 145 of the Internal Revenue Code of 1986, as amended (the "Code"), in one or more series from time to time pursuant to a plan of financing, in an amount not to exceed \$324,000,000 (the "Bonds"). The public hearing is required by Section 147(f) of the Code.
The proceeds from the sale of the Bonds will be used to make a loan to an affiliate of Community Finance Corporation, in order to pay all or a portion of the costs (a) to acquire and improve essential residential rental housing facilities, together with ancillary refail or commercial space, in several states, including two separate facilities located in the City (the "Facilities"); (b) to fund any required reserves; (c) to fund capitalized interest on the Bonds, if any; and (d) to finance costs of issuance of the Bonds, the Facilities will be owned by the Borrower and will be located at 1707 Owen Drive and 1944 Cedar Creek Road and expected to be acquired
