

PUBLIC HEARING NOTICE

FAYETTEVILLE CITY COUNCIL Paratransit Policy Changes

The Fayetteville City Council will hold a public hearing on **Tuesday, May 29, 2018, at 7:00 PM in the City Council Chamber, City Hall, 433 Hay Street, Fayetteville, NC 28301** to describe the following proposed changes and to receive comments from the public:

Route #11 Service Modification

Due to the loss in support funding Route #11 is proposed to operate 6:30am to 7:30pm, Monday-Saturday every 90 minutes along Ramsey Street, Country Club Drive, Pamalee Drive and Skibo Road. Route #11 would not operate on Murchison Road that duplicates Route#12 or along Langdon Street, Seabrook Road, or Jasper Street.

Individuals who would like to speak at the public hearing must register in advance with the City Clerk. The City Clerk's office is located on City Hall's 3rd Floor, 433 Hay Street, Fayetteville, NC 28301 and is open during normal business hours, from 8:00 AM to 5:00 PM. Citizens may register in person, via fax at (910) 433-1948, by email at cityclerk@ci.fay.nc.us, or immediately before the meeting in the City Council Chamber between 6:30 PM and 7:00 PM by giving their name and address.
