## **Relevant Experience & Education**

1. Summarize education, special skills and qualifications you have acquired from employment, previous volunteer work, or through other activities.

I have a Bachelor's Degree and two Master's Degrees: one in Management, and the other in National Security Strategy. I am a graduate of both the U.S. Army War College and the U.S. Air Force War College. I have 36 years of leadership experience at all levels of military command from Infantry Platoon Leader to Commanding General of a Division-sized element. I am a graduate of the Federal Senior Leader's Development Course. I have served and led numerous non-profit boards, committees, and clubs. I am trained in Federal Emergency Management was certified to command Federal and National Guard assets during declared emergencies and disasters. I am a graduate of the Defense Acquisition University and a Department of Defense Certified Professional Acquisition Program Manager with specialties in Science and Technology and Contracting.

2. Due to your financial interests, property ownership and/or other matters, personal conflicts of interest may arise during your appointment term. How would you handle a personal conflict of interest?

If a question of a conflict of interest should arise, I would immediately consult the City Attorney for advice to ascertain if the situation truly constitutes a legal conflict or the perception of a conflict. In either scenario, I would ask that the council excuse me from any vote on matters where the conflict might exist and/or divest myself of the business interest or resign from entities that were creating the conflict.

I do not currently have any financial or business interests that would create a conflict. The only property interest I have is my residence on Hillside Avenue. I currently serve on the board of directors for two non-profit organizations, which could request support from the City Council. I would request to be excused from voting on such requests.



3. Have you previously served on a board or commission? If so, please describe the scope of your appointment and share a few of the board's successes.

I have served on both the Fayetteville Historic Resources Commission and the Fayetteville Zoning Commission. The renaissance of the downtown was beginning during my tenure with Historic Resources. We worked to align the City guidelines with the Federal and State Historic properties guidelines. Additionally, we worked to ensure renovations and new construction downtown retained the character of the downtown and would be contributing structures (e.g new Police Station).

I served as the first Chairperson of the Fayetteville City Zoning Commission authorized by the State Legislature. I wrote the first set of the board operating procedures and submitted them to the Deputy City Manager.

## **Supplemental Questionnaire:**

- 1. Describe your background and interest in serving on the Fayetteville City Council. I believe in ethical and transparent government. The current situation offers a unique opportunity to serve my district and the city for a short period of time without the distractions of fund raising, campaigning, and catering to special interests that are sometimes necessary to the process, but are objectionable to me. I believe the current council is the most professional and dedicated council that we have had in years. I would be honored to be a contributing member representing the citizens of District 2 for the remainder of the term. As a long-term resident of District 2, I understand how socially and economically diverse the district is and how uniquely challenging inclusiveness is in that environment. Additionally, continued downtown redevelopment, balanced with other needs across the city will require compromise and cooperation amongst the council and perhaps, hard decisions. I am up for the challenge. As a potential selectee, I offer the council a non-threatening and uncontroversial choice. I haven't alienated any constituents in District 2 or the city by past electioneering, editorials, or other public statements.
- 2. Explain why you believe you would be an asset to the Fayetteville City Council. I believe that my many years of organizing and leading diverse, multi-dimensional large organizations, in volatile and complex environments that have mirrored issues facing the city, allow me to bring lesson-based experience and perspectives to inform and complement the decision-making process of the council. I understand the roles and functions of the City Manager and the City Council. I am accustomed to reviewing staff prepared proposals and documents. I routinely analyze budgets and data. As a Department of Defense Certified Professional Program Manager, I offer additional real world project management, budgeting, contracting, and procurement expertise to assist council deliberations. Importantly, my ethics and reputation are above reproach. I have established credibility with federal lawmakers and agencies as a retired General Officer.

I am accustomed to working with senior leaders in government and I would be comfortable representing the City of Fayetteville with our state government and legislature.

- 3. Are you willing and able to commit the amount of time necessary to fulfill the duties and expectations (attending meetings, reading agendas, answering e-mails) of becoming a member of the Fayetteville City Council? Yes, I am.
- 4. Will your employment allow you time away from you work on a regular basis? Yes.
- 5. The City of Fayetteville operates under a Council-Manager form of government. Explain your understanding of the Council's and Manager's role under this form of government. The City Manager serves at the pleasure of the Council and is the chief administrator of the city government, directing all the city departments in accordance with the general guidance of the City Council. The City Council governs, establishing the vision and strategy for the city and as a body represents the citizens of Fayetteville with other local, state, and national government entities.
- 6. Is there anything in your background that could bring your appointment into question or cause controversy/embarrassment to the City? No.
- 7. What experience and contacts do you have with the legislature at the State and Federal level? Throughout my career I have had multiple discussions at the Federal-level with staffers and lawmakers in the Senate and the House of Representatives. As a General Officer, I often have participated in panels, meetings, official delegations, lunches, and dinners with legislators. I most recently discussed cyber security issues with Senator Tillis. I will be participating as a panel member at DEFTEC this fall with both Senators Burr and Tillis. I have met most of the elected officials from Cumberland County at official or other community functions. I have the skills and willingness to address all local issues with our legislators at both the state and federal levels.
- 8. Please disclose any personal, professional/business or political relationships with PWC, the City of Fayetteville, City Council Members, or legislative delegation that could create the perception of undue influence or conflict of interest. I have no professional, business, or political relationships with the PWC, City of Fayetteville, City Council or other legislative delegation. I do know several members of the Council and other local, state, and federal elected or appointed officials on a casual social or professional basis. My wife is a staff employee of the Richardson Law Firm of which State Representative Billy Richardson is a partner.



9. What is the most urgent issue you believe the City must address that isn't already included in our Strategic Plan? In accordance with Goal III: High Quality Built Environment, Object E, the city needs to do more than just develop and sustain access to connectivity. The city must aggressively seek and address strategic partnerships to accelerate the build out of infrastructure to support the Internet of Things (IoT) and 5G and beyond communications platforms. For example, we are already lagging behind other North Carolina cities that are expanding access and capacity through Google Fiber. Affordable information access is a great equalizer. The future of a well-educated and employable citizenry and attracting growth and business development is dependent upon a flexible, expandable, and robust electronic infrastructure. That infrastructure will require public/private joint ventures.
