# 5.2 Agreement between the City of Fayetteville, North Carolina and the Fayetteville Metropolitan Housing Authority

Ms. Lisa Harper, Assistant City Attorney, presented this item and stated the Fayetteville Metropolitan Housing Authority (FMHA) and the City of Fayetteville (City) entered into an agreements on September 9, 1940, July 26, 1949, April 17, 1968, and November 15, 1972, pursuant to the Cooperation Agreements, FMHA proposed to develop and administer low-rent housing projects (Projects) within the jurisdiction of the City. Pursuant to the agreements, the City agreed to provide certain municipal or public services to FMHA, including among others, garbage, trash and ash collection. The City also agreed to not levy, impose or charge any taxes, special assessments, fees, charges or tolls against the Projects or against FMHA. The agreement constitutes the entire agreement between the parties and supersedes any prior agreement or understandings between them, oral or written, with respect to the matters addressed, all of which are hereby cancelled.
