### **Uniform Crime Reporting**

- The UCR Program compiles data monthly from law enforcement agencies which are transmitted directly to the FBI or SBI.
- The UCR Program is managed by the FBI.
- It was created in 1929 and collects information and crimes reported to law enforcement authorities.
- The hierarchy rule applies to UCR.



### National Incident-Based Reporting System (NIBRS)

- NIBRS is a nationally supported system which collects detailed information to include information about offense, victim, offender, property, and the arrestee.
- It includes all offenses within a single incident.
- The hierarchy rule is eliminated with NIBRS.
- We have transitioned to NIBRS as of November 1, 2018.
- The SBI is requiring North Carolina agencies to transition by January 1, 2019.
- The FBI is requiring agencies nationwide to transition to NIBRS by 2021.



#### **UCR vs. NIBRS**

- Unlike UCR, NIBRS includes all offenses within a single incident and additional aspects about each event.
- NIBRS will improve the detail and overall quality of crime data, which will help law enforcement and communities around the country use resources more strategically and effectively.
- BUT- Agencies can expect citizens to have the perception that crime has increased.



#### **UCR vs. NIBRS**

#### **Example**

- Two offenders robbed a bar at gunpoint. One of the robbers found a female customer in the restroom and raped her there without the knowledge of the other offender. When the rapist returned, both robbers left.
- With NIBRS, this would be two reports- one for the robbery and the other involving the rape, because the offenders were not acting in concert in both offenses.
- With UCR, this would be one report with one case number.

Aggravated Assault	823	996	+21.0%
Total	1,139	1,264	+11.0%

- Note: For 2018 Aggravated Assaults- 400 are classified as felonies.
- Seven (7) of the 19 homicides were related to domestic violence.



### January to September 2018 Aggravated Assault

Aggravated Assaults	2017	2018	Percentage of Change
Misdemeanor	525	596	+13.5%
Felony	305	400	+31.2%
Total	830	996	+20.0%

- 35% of aggravated assaults occurring in 2018 were related to domestic violence.
- In 2017, less than 10% of aggravated assaults were related to domestic violence.
- We have created a Domestic Violence Unit to combat the domestic violence trend.

The City of Fayetteville experienced 812 larcenies from vehicles for this time period, 598 of the 812 incidents (74%) were unsecured vehicles which is a significant drop from 85%-90% over previous years.

- Increased engagement & communication to the community
  - Implemented Citizens' Academy (waiting list for next class)
  - Created and implemented Faith-based Forum
  - Modified Community Watch Meetings with mandatory sworn personnel attendance




#### **Crime Fighting Strategies**

  - Partnered with the Fayetteville Police Foundation for funding opportunities
  - Secured grant to expand our EKG Program
  - Secured grant to implement Portable Fingerprinting System
  - Secured grant to implement training simulator
  - Secured grant funding to transition to NIBRS
- Increased social media platform
