7.02 SUP23-08. Order of Approval - Findings of Fact: Special Use Permit to allow a school to be located in a Single-Family 6 (SF-6) zoning district, located at 4502 Rosehill Road (REID # 0429683699000), and being the property of Bethel Christian Assembly Inc., represented by Del Crawford, Crawford Design Company. [Tabled from the October 23, 2023, City Council meeting]

The subject property is currently a vacant parcel owned by Bethel Christian Assembly Inc.. It is located between Fayetteville Christian Church Inc. and Warrenwood Elementary School, of the Cumberland County School System. It is also across the street from Gardners Chapel United Methodist Church. The property has been mostly undeveloped since at least 1968.

On October 23, 2023, the Fayetteville City Council held an evidentiary hearing regarding this case. After closing this hearing, a motion to table this item was made and approved. According to the draft minutes for this meeting, the following motion was made. "Council Member Benavente moved to remand this item back to staff to conduct objective research on the potential traffic impacts, and how this will affect the three schools in the area and ask the applicants to provide more specific evidence."

On November 13, 2023, the City Council continued deliberations for this evidentiary hearing. At the end of deliberations, the Council voted 9 to 1 in favor of issuing the requested Special Use Permit.

7.03 Adoption of Capital Project Ordinance Amendment 2024-9 for renovations to Orange Street School

Capital Project Ordinance Amendment CPOA 2024-9 to appropriate Cumberland County funding. CPOA 2024-9 will appropriate \$350,000.00 for the renovations to Orange Street School. The County will contribute \$350,000.00 for the fixtures, furniture, and equipment ("FFE") for the restored school in its FY 24 budget. The City will oversee the FFE purchases for the school and place the items into use. The County will make one lump sum payment to the City after the execution of the agreement. The agreement shall terminate when the project is completed.

7.04 Adoption of Capital Project Ordinance 2024-11 to Appropriate North Carolina Department of Transportation Grant Funding for the Environmental & Design Phases of Taxiways Foxtrot and Golf Rehabilitation

Capital Project Ordinance (CPO) 2024-11 to appropriate \$500,000.00 of State grant funds for an airfield pavement project. The source of funding is the North Carolina Department of Transportation's Division of Aviation.

7.05 Adoption of Budget Ordinance Amendment 2024-8 to appropriate the 2023 Motiva First Responder Grant

Budget Ordinance Amendment 2024-8 to appropriate \$10,000.00 of the 2023 Motiva First Responder Grant. It will be used to send two personnel to the 2024 Xtreme Industrial Fire and Hazard Training School in College Station, Texas. The two attendees will return and train the remaining department members on the proper strategies and tactics in combating industrial fires.

7.06 Adoption of Budget Ordinance Amendment 2024-9 for the Fiscal Year 2023-2024 to move Cape Fear Regional Theater funds from Other Appropriations to Economic and Community Development

During the adoption of the FY 2023-24 Operating and Capital Budget, the City Council allocated \$500,000.00 for capital support to the Cape Fear Regional Theater. As part of the administration of those funds, the Council is asked to adopt Budget Ordinance Amendment 2024-9 to move \$500,000.00 of funding for the Cape Fear Regional Theater from Other Appropriations to Economic and Community Development. Moving the funds to Economic and Community Development would provide more direct oversight and tracking of these funds.

7.07 Adoption of Special Revenue Fund Project Ordinance 2024-12 to Appropriate the FY23 Edward Byrne Memorial Justice Assistance Grant (JAG)

The City has been awarded grant funding for fiscal years 2023-2026 from the Edward Byrne Memorial Justice Assistance Grant (JAG) Program. Council is asked to adopt Special Revenue Fund Project Ordinance 2024-12 to accept the FY23 grant funding and appropriate \$119,912.00 needed to increase operational efficiency, improve officer safety, and upgrade safety equipment. The grant will be used for C50 Avon gas masks to improve communication and add protection to the operators against exposure to substances such as fentanyl. Additionally, the funds will be used for rifle flashlight equipment, a breaching robot to reduce safety threats and a 28-bay cell phone charging locker for evidence extraction purposes.

7.08 Award of Terminal Renovations Phase III Construction Contract to Daniels & Daniels Construction Company, Inc., and Authorization for the City Manager to Execute the Contract

Award the contract for construction of Terminal Renovations Phase III to Daniels & Daniels Construction Company, Inc., as the successful bidder of the bid process completed September 12, 2023.

7.09 Authorize the execution of an engineering service contract for professional services for Phase 1 Watershed Study for Buckhead Creek

Authorize the execution of an engineering service contract for professional services for \$855,355.00 for Phase 1 Watershed Study for Buckhead Creek as part of the Watershed Master Plan program to the consulting firm Gradient, PLLC.

7.010 Approve Resolution Authorizing Municipal Agreement with the North Carolina Department of Transportation for the Review of Plans and Documents associated with the Blanton Road Extension Project

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAYETTEVILLE FOR NCDOT REVIEW OF THE BLANTON ROAD EXTENSION PROJECT. RESOLUTION NO. R2024-002

The City has requested that NCDOT provide review of certain items related to the transportation improvements of Blanton Road. These improvements will affect the State Highway System and will potentially

be funded in the future with Federal or State funding administered through the North Carolina Department of Transportation (NCDOT). NCDOT provides oversight for Federal Highway Administration (FHWA) and is responsible for plan reviews including Traffic Impact Analysis, Roadway, Environmental, Traffic Noise, Hydraulics, Erosion Control, Signals, Pavement Marking/Signing, Traffic Control, Structures, and Geotechnical disciplines. The estimated cost to review provided by NCDOT is \$54,600.00. The City is currently designing the Blanton Road Extension Project and this municipal agreement will allow for the project to move forward without any delay.

7.011 Approval of a Municipal Agreement with NCDOT for the update to the Fayetteville Comprehensive Pedestrian Plan

Approval of a Municipal Agreement with the North Carolina Department of Transportation (NCDOT) for the update to the Fayetteville Comprehensive Pedestrian Plan. The estimated cost of the Project is \$142,500.00 with a 50 percent cost share from the City of \$71,250.00. All costs that exceed the estimated total cost of \$142,500.00 would be the City of Fayetteville's responsibility. Council adopted the FY2024 Budget Ordinance on June 21, 2023, which appropriated \$100,000.00 in the general fund for the pedestrian and bicycle project.

7.012 Approval of a Municipal Agreement with the NCDOT Project B-4490(L) for landscaping and irrigation at the intersection of Bragg Boulevard and Rowan Street

The cost of the project is \$49,031.00. City Council adopted the FY2024 Budget Ordinance on June 21, 2023, which appropriated \$50,000.00 in the general fund for Project B-4490(L).

Rezoning of 1.86 acres ± from Mixed Residential 5 (MR-5) to Downtown 2 Conditional (DT-2/CZ), located at 344, 348, and 352 Hawley Lane and unaddressed Plummers Lane (REID #s 0437848219000, 0437848347000, 0437848464000, and 0437849540000), and being the property of Cumberland County Board of Education, Michael J Carpenter and Helen Kelly Heirs, represented by Jimmy Kizer, Moorman, Kizer & Reitzel, Inc., and Jermaine Walker, Cumberland County.

Mr. Craig Harmon, Senior Planner, presented this item and stated the applicant has requested to conditionally zone four adjoining properties on Hawley and Plummers Lanes from Mixed Residential 5 (MR-5) to Downtown 2 Conditional Zoning (DT-2/CZ). The only proposed condition is to allow an adjustment to the maximum setback distance. The proposed tenant is a Transitional Shelter Facility owned by Cumberland County. The Unified Development Ordinance (UDO) also requires a Special Use Permit (SUP) in the DT-2 district to operate this type of use. An application for a SUP has been applied for. According to the applicant, the Cumberland County government would like to construct a transitional housing facility to include educational services on land adjacent to an existing Cumberland County Schools Facility that is currently used by FTCC for vocational training. A new building is planned along with the associated parking, access, utilities, and landscaping improvements.

The proposed facility would be used to temporarily house homeless citizens and provide them with services and assistance to help them to transition back to a stable quality of life. The facility will be used 24/7, with a larger staff being present during weekly and daily working hours to assist residents. The facility will always house staff to help monitor and minimize the movement of residents during non-working hours.

This is the advertised public hearing set for this date and time. The public hearing was opened.

10.0 EVIDENTIARY HEARINGS

10.01 SUP23-09. Special Use Permit to allow Transitional Housing at 344, 348, and 352 Hawley Lane and unaddressed Plummers Lane (REID #s 0437848219000, 0437848347000, 0437848464000, and 0437849540000), and being the property of Cumberland County Board of Education, and Cumberland County, represented by Jimmy Kizer, Moorman, Kizer & Reitzel, Inc. and Jermaine Walker, Cumberland County.

Mr. Craig Harmon, Senior Planner, presented this item and stated the proposed tenant is a Transitional Shelter Facility to be owned by Cumberland County. The Unified Development Ordinance (UDO) requires a Special Use Permit (SUP) in the DT-2 district to operate this type of use. As part of the Council's consent agenda is a request to rezone these properties to DT-2/CZ. The use in question is not allowed in the Current MR-5 - Mixed Residential 5 district.

The applicant is requesting a Special Use Permit to build and operate a Transitional Housing shelter on the properties in question. According to the applicant Cumberland County, they would like to construct a transitional housing facility adjacent to the existing Cumberland County Schools Facility that is currently being used by FTCC for vocational training. The proposed facility would be used to temporarily house homeless citizens and provide them services and assistance to help them transition back to a stable quality of life. The facility will be used 24/7, with a larger staff being present during weekly and daily working hours to assist residents. The facility will house staff at all times to help monitor and minimize the movement of residents during non-working hours.

The application is only to address the allowance of a Transitional Housing shelter. Hthe SUP must meet the following findings of facts:

- (1) The special use complies with all applicable standards in Section 30-4.C, Use-Specific Standards; According to Section 30-4.C.2.b.6. Transitional Housing;
- (2) The special use will be in harmony with the area in which it is located;
- (3) The special use will not materially endanger the public health or safety if located where proposed and developed according to the plan as submitted and approved;
- (4) The special use is in general conformity with the City's adopted land use plans and policies;
- (5) The special use will not substantially injure the value of the abutting land, or the special use is a public necessity; and
- (6) The special use complies with all other relevant City, State, and Federal laws and regulations.

The applicant states that they "will comply with all other relevant City, State, and Federal laws and regulations".

This is the advertised public hearing set for this date and time. The public hearing was opened.

And that the application is consistent with applicable plans because (1) the development is located in the Downtown 2 zoning district, (2) the transitional housing will comply with all six of the findings of fact, and (3) the proposed permit is in the public interest because the proposed SUP does fit with the character of the area and will help the choices for the homeless population in Fayetteville. If approved, this Special Use Permit shall become effective with the approval of the Order of Findings by the City Council. The SUP shall expire one year from its effective date if a building permit is not issued within that time. All of the following six findings must be met:

- (1) The special use complies with all applicable standards in Section 30-4.C, Use-Specific Standards;
- (2) The special use will be in harmony with the area in which it is located;
- (3) The special use will not materially endanger the public health or safety if located where proposed and developed according to the plan as submitted and approved;
- (4) The special use is in general conformity with the City's adopted land use plans and policies;
- (5) The special use will not substantially injure the value of the abutting land, or the special use is a public necessity; and
- (6) The special use complies with all other relevant City, State, and Federal laws and regulations

Any remaining speakers on the Public Forum list that did not get an opportunity to address the City Council will have the option to have their name placed at the beginning of the next scheduled public forum list of speakers.
