10.02 Refunding the outstanding maturities of General Obligation Public Improvement Bonds, Series 2005 maturing June 1, 2020 through June 1, 2025. Adopt Preliminary Resolution / Bond Order (Refunding); File Sworn Statement of Debt / Statement of Estimated Interest

Mr. Jay Toland, Chief Financial Officer, presented this item and stated the City plans to issue the first of three issuances of Parks and Recreation General Obligation Bonds in May of 2019. With this first issuance is an opportunity to refund (refinance) General Obligation Public Improvement Bonds, Series 2005, to realize lower interest cost. The cash flow savings are as follows:

2019 - \$290.00 2020 - \$24,998.00 2021 - \$25,288.00 2022 - \$28,663.00 2023 - \$25,313.00 2024 - \$27,000.00 2025 - \$28,688.00 Total - \$160,238.00 Net Present Value - \$145,103.00

Mr. Toland stated an analysis of current market rates indicates that the City is able to realize debt service savings by refunding the outstanding maturities of its General Obligation Public Improvement Bonds, Series 2005 maturing June 1, 2020 through June 1, 2025, inclusive. As provided in the analysis, based on an estimated interest rate, the City would be able to realize net present value savings of \$145,103.00 or 5.80 percent of the refunded per amount. First Tryon Advisors is serving as Financial Advisor to the City. Womble Bond Dickinson (US) LLP and the Charleston Group are serving as Co-Bond Counsel. The City is planning on selling the General Obligation Refunding Bonds, Series 2019, in the public market in conjunction with a series of new money General Obligation Bonds. The City is scheduled to sell Bonds on May 7, 2019.
