### Transit Administration Grant Award NC-2019-021-00 for Various Capital Items and Planning Activities

The Federal Transit Administration has awarded Transit Grant NC-2019-021-00 to provide federal funding for eligible projects in support of the City's transit activities. The grant includes \$2,603,000.00 in FTA grant funds to reimburse the City for preventive maintenance, a portion of ADA paratransit services and operating activities performed during FY 2019. These revenues were already appropriated as a part of the FY 2019 annual operating budget for the Transit Fund. In addition to the operating funding above, the grant includes \$764,600.00 for capital items including replacement paratransit and support vehicles, shelters and benches, construction of ADA accessible bus stops and related sidewalks, major bus maintenance components, and 4G-capable mobile data terminals for vehicles. Capital Project Ordinance 2019-32 will appropriate \$634,480.00 in grant funds from the FTA and a \$130,120.00 transfer from the Transit Operating Fund for these items. The grant includes \$86,000.00 for various transit planning activities and employee training, and Special Revenue Fund Project Ordinance (SRO) 2019-11 will appropriate \$68,800.00 in FTA grant funds and \$17,200.00 to be transferred from the Transit Operating Fund for these activities.

- 1. The City of Fayetteville Requesting funding to support the development of a Stormwater Resilience Master Plan to study the impacts of stormwater on properties City-wide. The estimated cost for the plan is \$1 million.
- 2. The City of Fayetteville and several community partners are making efforts to development a Tier 1 Study/Action Plan to delineate how the City and its partners can best position the community to take advantage of the incentives provided for Tier 1 communities from the North Carolina Department of Commerce. The estimated cost of this plan is \$500,000.00.

- The City of Fayetteville is seeking support for an Environmental Improvement Plan to study areas in and around the river. This study would seek the best solutions available to lessen the negative impacts on our citizens during storm events. The estimated cost of this plan is \$500,000.00.
- The City of Fayetteville is seeking support to develop "Smart City" capacity through pursuing the installation of broadband across the City through funding support to do a connection study and implementation plan. The estimated cost of this plan is \$500,000.00.

#### 9.0 OTHER ITEMS OF BUSINESS

9.01 Approval of sale and issuance of Limited Obligation Bonds -Baseball Stadium and Parking Deck Improvements and A New Pool

Mr. Jay Toland, Chief Financial Officer, presented this item and stated Council is asked to consider the final approving resolution to authorize the City to sell an amount not to exceed \$7,300,000.00 in limited obligation bonds. The purpose is to finance one or more of the following projects: (a) certain additional costs relating to acquisition, construction, and equipping of a baseball stadium; (b) certain additional costs relating to the acquisition, construction, and equipping of a parking deck; and (c) the cost of constructing and equipping a new pool at the Lake Rim Recreation Center. The current forecasts are \$2.5 million for the Baseball Stadium, \$3 million for the Lake Rim Pool, and \$1.5 million for the Parking Garage with a grand estimated total of \$7 million. Actual figures and issuance costs will be used for the application to the Local Government Commission.

### 9.02 Presentation of the Recommended Fiscal Year 2019-2020 Budget and Setting of the Budget Public Hearing

Mr. Douglas Hewett, City Manager, presented this item with the aid of a PowerPoint presentation. Mr. Hewett thanked Ms. Tracey Broyles, Budget and Evaluation Director, and all of her staff and the City Manager's office for all of the hard work put into this project.

Mr. Hewett stated the proposed FY 2020 annual operating budget of \$228,814,977.00, excluding internal service funds, is \$13,445,607.00 more than the original budget for FY 2019, an increase of 6.2 percent. Excluding an increase of \$9,637,242.00 in transfers for capital projects, the year-over-year increase is \$3,808,365.00 or 1.8 percent. For the general fund in particular, the proposed budget is \$173,799,332.00, an increase of \$4,793,014.00 or 2.8 percent of the original adopted budget for the current fiscal year. The tax rate to support the general fund is recommended to remain at 49.95 cents per \$100.00 of assessed valuation.

Mr. Hewett provided an overview of the following topics: Cost of Quality Government Service, Expenditure Highlights, Goal 1: Safe & Secure Community, Goal 2: Diverse & Viable Economy, Goal 3: High Quality Built Environment, Goal 4: Desirable Place to Live, Work and Recreate, Goal 5: Sustainable Organizational Capacity, Goal 6: Citizen Engagement, Partnerships, and Revenue Highlights.

The Path Forward; the proposed budget focuses on maintaining a solid base of core services, advancing the City Council strategic goals, and timely completion of key capital projects that will continue to transform our community. Other than the changes highlighted herein, the budget provides the resources needed to stay on our current ambitious course. While this budget strikes a careful balance in maintaining our services as a major metropolitan area, it also ensures that we are ready to respond if the unexpected occurs.
