7.03 Adoption of Budget Ordinance Amendment 2021-13 for the General Fund, Central Business Tax District Fund, Lake Valley Drive Municipal Service District Fund, and Fleet Maintenance Internal Service Fund

Budget Ordinance Amendment 2021-13 to adjust annual operating budgets for the General Fund (\$2,148,400.00), Central Business Tax District Fund (\$5,000.00), the Lake Valley Drive Municipal Service District Fund (\$1,003.00) and the Fleet Maintenance Internal Service Fund (\$783,000.00) to ensure sufficient budget is available to meet year-end expenditure projections developed with the Fiscal Year 2022 budget process, to provide for additional funding needs recently identified, and to ensure sufficient budget availability should unexpected expenditures arise before the close of the fiscal year.

7.04 Adoption of Capital Project Ordinance Amendment 2021-58 for Final Closeout Payment for an NCDOT Municipal Agreement for Irrigation and Landscaping Improvements on Owen Drive

Capital Project Ordinance Amendment 2021-58 to appropriate \$7,776.00 for a final payment to the North Carolina Department of Transportation (NCDOT) for irrigation and landscaping improvements on Owen Drive. Council approved a Municipal Agreement for this project in August 2017, and in February 2019 the City received a final invoice from NCDOT for our cost share of the project. The Capital Project Ordinance was subsequently closed out in Fiscal Year 2020. The NCDOT has now determined during its closeout and audit process that the City was not properly invoiced for our cost share on this project and has submitted an amended final billing.

7.05 Adoption of Capital Project Ordinance Partial Closeouts for Municipal Agreements Projects 2021-1 and Stormwater Drainage Improvements Fund Ordinance Partial Closeouts for 2021-15, 2021-18, and 2021-19

Capital Project Fund Ordinance Partial Closeout 2021-1 is for Transportation Fund Municipal Agreement projects such as sidewalks, landscaping, pedestrian safety, and a traffic signal. Each of the projects being closed have been completed. The partial closeout results in \$7,230.00 being made available for use in other Transportation Municipal Agreement capital projects.

Capital Project Fund Ordinance Partial Closeout 2021-15 is for Fiscal Year 2015 stormwater drainage improvement and other capital expenditures including, Godfrey Outfall, Ferncreek Norwood, and Spot Repair Program. The partial closeout results in \$1,447,883.00 being made available for use in other Stormwater capital projects.

Capital Project Fund Ordinance Partial Closeout 2021-18 is for Fiscal Year 2016 stormwater drainage improvement and other capital expenditures including, Spruce Street Phase II. The partial closeout results in \$1.00 being made available for use in other Stormwater capital projects.

Capital Project Fund Ordinance Partial Closeout 2021-19 is for Fiscal Year 2017 stormwater drainage improvement and other capital expenditures, including Emergency Repair at McGilvary, Spot Repair, and Shoreline Drive Culvert. The partial closeout results in \$780,436.00 being made available for use in other Stormwater capital projects.

All of the projects were completed in previous fiscal years, audited by the City's external auditors as part of the annual audit process and are ready for closure. Each closeout provides a brief description of the project, the year the project ordinance was adopted, and the final revenue and expenditure budgets and actuals that are being closed.

7.06 Updated Memorandum of Understanding (MOU) with the Fayetteville Area Metropolitan Planning Organization (FAMPO)

The Fayetteville Area Metropolitan Planning Organization (FAMPO) is requesting approval of a revised Memorandum of Understanding (MOU) with all its member jurisdictions, including the City of Fayetteville. The significant change in this revised MOU is the member from Fort Bragg becomes a voting member, as opposed to a non-voting member, on the FAMPO Transportation Policy Board (TPB). Other changes include updating position title descriptions that had changed since the prior revision to the MOU. The MOU was recommended for approval by the TPB that includes City of Fayetteville Council Members Dawkins and Wright.

7.07 Award Contract for the Purchase of Three Chevrolet Forensic Cargo Vans.

Award a contract for the purchase of three Chevrolet Forensic Cargo Vans for the Police Department. The recommended lowest responsive bidder is Cooper Ford, Carthage, NC, in the total amount of \$98,400.00.

9.01 Adoption of the Fiscal Year 2021-2022 Budget Ordinance and Fee Schedule, the Fiscal Year 2021-2022 Strategic Plan, the Fiscal Years 2022-2026 Capital and Technology Improvement Plans, Capital Project Ordinances 2022-1 through 2022-12, Capital Project Ordinance Amendments 2022-1 through 2022-27, and Special Revenue Fund Project Ordinance Amendment 2021-1

Mr. Douglas Hewett, City Manager, presented this item with the aid of a PowerPoint presentation and stated Council is asked to consider adoption of the Fiscal Year 2021-2022 Budget Ordinance and Fee Schedule which incorporates changes to the recommended budget based upon consensus direction provided by Council at the May 27, 2021, budget work session. In addition to setting the ad valorem tax rate at 49.95 cents and the Central Business Tax District rate at 10 cents, the ordinance also levies the stormwater fee at \$6.00 per month and the residential solid waste fee at \$225.00 per year, and adopts the fee schedule presented.

Council is also asked to approve the Fiscal Year 2021-2022 Strategic Plan and the Fiscal Year 2022-2026 Capital and Technology Improvement Plans (CIP and TIP), and to adopt related capital project ordinances, capital project ordinance amendments and special revenue fund ordinance amendments to establish project budgets as planned.
