Relationship To Strategic Plan:

Goal 4: The City of Fayetteville will be a highly desirable place to live, work and recreate with thriving neighborhoods and a high quality of life for all residents.

Executive Summary:

The Federal Transit Administration (FTA) has awarded the City's urban formula grant for federal fiscal year 2017. The grant includes pre-award authority for expenditures retroactive to July 1, 2016.

The grant provides \$2,196,000 of federal funds for operating assistance, preventive maintenance and ADA paratransit service support. Those grant funds were appropriated with the fiscal year 2017 Transit operating budget.

The grant also provides \$683,802 for capital items. Capital Project Ordinance 2017-55 will appropriate \$854,752 for the \$683,802 federal grant funds (80%) and the required \$170,950 local match (20%) for capital items as itemized in the background section below.

Background:

The City is the Designated Recipient for federal transit grant funds apportioned to the Fayetteville urbanized area. Each year, the Transit Department must apply for use of the funds and execute a grant with the FTA in accordance with the adopted State Transit Improvement Plan (STIP). The FTA recently awarded the grant for FY 2017 with \$2,978,802 of Section 5307 funding to support total planned expenditures of \$4,199,752.

This grant provides \$2,196,000 of federal reimbursements for preventive maintenance, ADA paratransit services, and other operating expenditures incurred from July 1, 2016 through June 30, 2017. These funds, along with the required local matching funds, were included in the FY 2017 operating budget.

This grant also provides \$683,802 of grant funding to support \$854,752 of capital expenditures including: replacement security camera systems for buses and vans; major repair components for buses and propane conversion kits for vans; installation of ADA accessible bus stops, shelters and benches; and, acquisition of shop equipment including a mobile bus lift and a pump for a diesel storage tank.

Issues/Analysis:

Budget Impact:

The current fiscal year 2017 Transit Operating Fund budget includes funding for the required local match for the operating and capital grants.

Options:

- 1) Adopt Capital Project Ordinance 2017-55 to appropriate the funding for the capital items.
- 2) Do not adopt Capital Project Ordinance 2017-55 and provide further direction to staff.

Recommended Action:

Staff recommends that Council move to adopt Capital Project Ordinance 2017-55 as presented to fund the capital items approved in the FY 2017 Section 5307 grant.
