#### Relationship To Strategic Plan:

Goal 4: The City of Fayetteville will be a highly desirable place to live, work and recreate with thriving neighborhoods and a high quality of life for all residents.

#### **Executive Summary:**

Council is asked to adopt Budget Ordinance Amendment (BOA) 2023-4 and Capital Project Ordinance (CPO) 2023-9 to appropriate \$150,000.00 for the Rowan Park Improvement Project.

#### **Background:**

Rowan Park has seen a significant increase in visitors since the opening of the new Skate Park and the conversion of the old tennis courts to pickle ball courts.

Improvements are recommended to the upper level of Rowan Park and include, but are not limited to, shade structures adjacent to the pickle ball courts and erosion control measures to ensure stabilization of the ground.

#### **Budget Impact:**

Budget Ordinance Amendment 2023-4 will appropriate \$150,000 from the General Fund fund balance.

### **Options:**
